ORDER:-

In the letter 1st read above, the Secretary to Government & Commissioner Industrial P, Industries & Commerce Department, Government of Andhra Pradesh while communicating the revised frame work for assessing state reforms and implementation with 340 interventions has requested to ensure compliance of the said recommendations.

2. In the letter 3rd read above, the Director of Factories, Andhra Pradesh, Hyderabad while stating the circumstances has furnished proposal requesting notify territorial jurisdiction for inspection of factories by the officers of the Factories Department in a Zone for inspecting factories in any of the districts / circles within the zone that the same Inspector will not inspect the same establishment twice consecutively,

3. After careful examination of the matter, the Government hereby issues the following orders to ensure that the same Inspector will not inspect the same establishment twice consecutively with a view to comply with DIPP recommendations, 2016 for enabling Ease of Doing Business while ensuring simplification, transparency and accountability in Governance.

The following notification will be published in the next issue of the Andhra Pradesh Extraordinary Gazette.

NOTIFICATION

In exercise of the powers conferred by sub-sections (1) and (6) of Section 8 of Factories Act, 1948 (Central Act 63 of 1948), the Governor of Andhra Pradesh hereby appoints the persons specified in column (1) of the Schedule below to be the Inspectors for purpose of the said Act (Inspection of factories only) and assigns to them the respective local limits mentioned against each of them in column (2) thereof and declares that the said Inspectors shall exercise the powers of Inspectors under the said Act (Inspection of factories only) in the jurisdictions assigned to them.
